1. State Finances – PAR’s report analyzed a number of the state’s fiscal problems and recommended changes to improve the budget-making process.

3. Contracting for Legal Services – PAR is preparing for publication a report of the comprehensive study of the procedures and practices of Louisiana state and local public entities in contracting with private attorneys for legal services.

PAR’s 50th Anniversary Celebration in 2000 included the publication of a book on PAR’s first fifty years, a television documentary on PAR’s work that was shown statewide several times, special anniversary luncheons that took place in all the large cities of the state, and editorials on PAR’s work in the major daily newspapers.
2. PAR’s commentaries and reports garnered extensive media coverage. The number of press and electronic news references to PAR increased by approximately 70% over the previous years.
3. Finances/Development – Revenues generated by PAR in 2000 exceeded expenses for the year by over \$100,000. Major gifts and foundation grants were largely responsible for the revenue gains.
